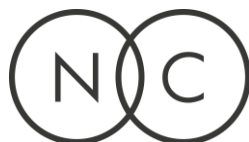

PACKAGING AND TRANSPORT

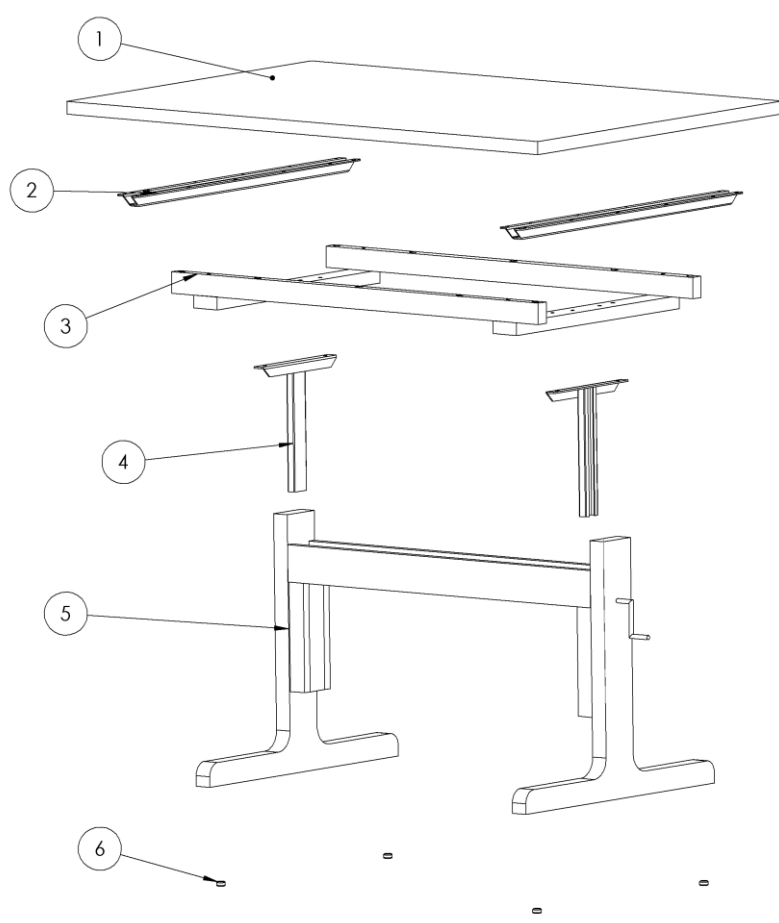
